This is My Witness follows the journey and personal transformation of two women who go to New York to tell their stories of brutality at the hands of the military regime in Burma. Inspired by the example and leadership of their beloved Aung San Suu Kyi, the women join a global movement to bring democracy to Burma.

## SYNOPSIS

In New York City on March 2<sup>nd</sup>, 2010, one-by-one, twelve courageous women from Burma stood before a microphone to tell their stories to the world. They recounted their experiences of rape, assault, imprisoned, torture and forced labour, at the hands of soldiers of the Burmese military government.

In this very first People's Tribunal on Crimes Against Women in Burma, the testifiers were heard by a panel of expert judges. Their testimony was recorded and their calls for justice in Burma were actualized in a set of recommendations issued by the judges, to the Burmese regime and to the international community.

*This is My Witness* is an intimate portrayal of two of the testifiers and their journeys through the experience of preparing for and delivering their testimony at the Tribunal. We first meet with women in their respective homes as they anticipate leaving to travel to New York. Testifying will not be easy, the memories of what happened are still vivid and emotions lie close to the surface. We witness their heartbreaking testimony and in the aftermath a transformation, intense satisfaction that the truth has been told, certainty about the just nature of their cause and their dreams for the Burmese people.



Saw Myat Mar, a supporter and friend of Aung San Suu Kyi, was arrested and held as political prisoner for several years in the notorious Insein prison. Now living a comfortable middle class life in San Jose California she can never forget what happened nor those she left behind. By agreeing to testify she uses the only weapon she has, the truth about what happened to her in Burma.



Living in poverty and on the margins as a refugee in Bangladesh Saw Ma Pu Sein was forced by the Burmese military to build roads by hand. When she became ill and her ten-year old daughter was forced to replace her on the crew, Ma Pu Sein knew that she could no longer remain in Burma. She fled, leaving her mother behind, whom she has not seen since.

Saw, Ma Pu Sein and the other testifiers confront us with the truth about crimes against women in Burma and challenge us, the international community, to face up to our responsibility to protect the people of Burma from human rights violations. They have knowingly put themselves at risk by speaking out publicly and telling their stories, they are courageous catalysts for change.

*This is My Witness* reaches viewers on an emotional level. It opens a window on the devastating impact that the actions of the Burmese military regime have had on individuals and their families. Its purpose is a call to action.

Jith Paul is a filmmaker based in Ottawa, producer of the short film *Polar Bear Love*, winner of the Judges' Favourite award at the Ottawa International Film Festival's 72 hour film challenge 2011. He directed *Documenting Dreams* an official selection at the Ottawa International Film Festival 2010 and edited *This is My Witness*. Jith is the president of Treepot Media Inc., a company he founded in 2010. He collaborates with local artists, musicians and filmmakers to broadcast content on a web television channel called Treepot.tv.
